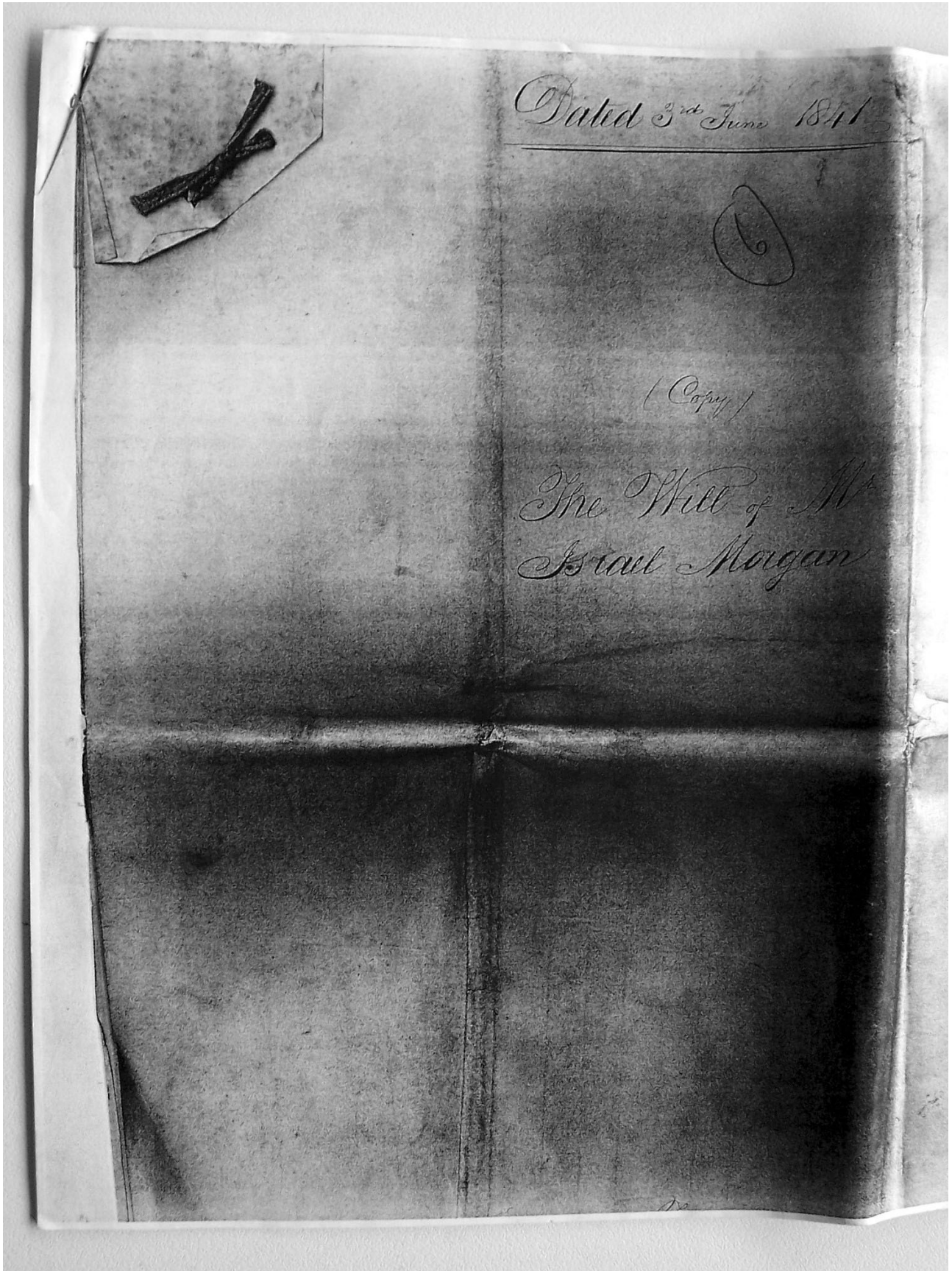

This is the last Will and Testament of me
Isaiah Morgan of the Parish of Stanwernarth in the
County of Monmouth Yeoman I Give and ~~bequeath~~^{devise} all my Faithful
Property situate lying and being in the several Parishes of
Stanwernarth Stanraun and Gortney in the County of Monmouth or elsewhere
unto my dear Wife Anne for and during the Term of her natural life
so long as she shall continue my Widow for the purpose of enabling her to
bring up clothe and Educate my four Children by her Obedience and
after her decease or second Marriage I Give and devise the said Estates
unto my friends Walter Lewis of the Parish of Stanwernarth aforesaid Gen
and William Lewis of the Parish of Stantillow Pertholey in the said
County Yeoman and the Survivor of them and the heirs of such Survivor
Upon the Trusts hereinafter mentioned that is to say As to for and
concerning my said Estates situate in the Parish of Stanwernarth Upon
Trust that my said Trustees or the Survivor of them or the heirs Executors or
Administrators of such Survivor do and shall from and immediately after
the decease or second Marriage of my said Wife set out and manage and
receive the Rents Issues and Profits thereof and apply such portion of the
same as to them my said Trustees or the Survivor of them or the Heirs
Executors or Administrators of such Survivor shall think requisite in the
maintenance education and support of my Eldest Son John until he
shall attain the age of Twenty one Years and upon his attaining that age
I Give devise and bequeath the same with all accumulations of the Rents
thereof unto him his Heirs and Assigns for ever But in the event of my
Son John dying under the age of Twenty one Years and without having
Issue lawfully begotten by him then Upon Trust that my said Trust
or the Survivor of them or the Heirs of such Survivor do stand possessed of
my said Estates in the Parish of Stanwernarth aforesaid Upon Trust
set out and manage the same and receive the Rents Issues and Profits
thereof until my second Son William shall attain the age of Twenty
Years and upon his attaining that age I Give devise and bequeath
same with all accumulations of the Rents thereof unto him his Heirs and
Assigns for ever And as to and concerning all that my Estate situate
in the Parishes of Stanraun and Gortney in the said County of Monmouth
I Give and devise the same after the decease or second Marriage of my
said Dear Wife Anne unto the said Walter Lewis and William Lewis

and the Survivor of them and the Heirs of such Survivor Upon trust that they my said Trustees or the Survivor of them or the Heirs Executors or Administrators of such Survivor do and shall from and immediately after the decease or second Marriage of my said dear Wife set out and manage and receive the Rents Issues and Profits thereof and apply such portion of the same Rents and Profits as to them my said Trustees or the Survivor of them or the Heirs Executors or Administrators of such Survivor shall think requisite in the maintenance education and support of my said Son William until he shall attain the age of Twenty one Years and upon his attaining that age I GIVE devise and bequeath the same with all accumulations of Rents unto him his Heirs and Assigns for ever But in the event of his death under that age and without leaving Issue lawfully begotten by him then and in such case I GIVE and devise the said last mentioned Estate unto my Eldest Son John his Heirs and Assigns for ever I GIVE and bequeath my Household Furniture Farming Stock Implements of Husbandry and Crops unto my dear Wife Anne her Executors and Administrators for her own sole use and benefit I ALSO give and bequeath ^{all monies} due to me on Mortgage Bonds Bills Notes or otherwise howsoever and all other my Personal Estate and Effects of what nature or kind soever unto the said Walter Lewis and William Lewis their Executors Administrators and Assigns Upon trust that they my said Trustees or the Survivor of them or the Executors or Administrators of such Survivor do and shall stand possessed of the same and of the Securities upon which the same are remaining Upon trust to pay the Interest Dividends and Annual proceeds thereof unto my said dear Wife Anne if she continues my Widow until my Eldest Daughter Sarah shall attain the age of Twenty one Years and upon her attaining that age Upon trust after deducting the sum of Six hundred pounds therefrom to stand possessed of one Moiety of the remainder thereof Upon trust to invest the same upon Government or good real Security and to pay the Interest Dividends and Annual proceeds thereof unto my said Daughter Sarah for the Term of her natural life for her sole and separate use and benefit independant of and free from the Debts Engagements and Control of her present or any future Husband and from and after her decease Upon further Trust that they my said Trustees or the Survivor of them or the Executors Administrators or Assigns of such Survivor do and shall stand possessed of the said Moiety Upon trust to

divide the same equally between all the Children of my said Daughter Sarah or the Issue of such of them as shall have died leaving any that may happen to be living at the time of her decease share and share alike when and as they shall severally and respectively attain the age of Twenty one Years And in case there shall be no Child or Children of my said Daughter Sarah or the Issue of any living at the time of her decease then I direct my said Trustees or the Survivor of them or the Executors Administrators or Assigns of such Survivor to divide the same so vested in them as aforesaid between such of my Children or the Issue of either of them as shall then be living share and share alike and as to the other Money thereof Upon trust that they my said Trustees or the Survivor of them or the Executors Administrators or Assigns of such Survivor do invest the same upon such Security as aforesaid And pay the Interest Dividends and Annual proceeds thereof unto my said Dear wife Anne if she continues my widow until my Youngest Daughter Rebecca shall attain the age of Twenty one Years and upon my said daughter Rebecca attaining that age Upon trust to pay such Interest Dividends and Annual proceeds unto her for the Term of her natural life for her use sole and separate use and benefit independent of and free from the debts engagements and controul of any Man with whom she may happen to intermarry and from and after her decease Upon further Trust that they my said Trustees or the Survivor of them or the Executors Administrators or Assigns of such Survivor do and shall stand possessed of the said last mentioned moiety of my said Personal Estate Upon trust to divide the same equally between all the Children of my said daughter Rebecca or the Issue of such of them as shall have died leaving any that may happen to be living at the time of her decease share and share alike when and as they shall severally and respectively attain the age of Twenty one Years And in case there shall be no Child or Children of my said Daughter Rebecca or the Issue of any living at the time of her decease Then I direct my said Trustees or the Survivor of them or the Executors Administrators or Assigns of such Survivor to divide the said last mentioned Money so vested in them as aforesaid between such of my Children or the Issue of either of them that may be living at the time of the decease of my said Daughter Rebecca share and share alike And I do hereby declare that the receipt of my said Daughter

respectively shall alone be a sufficient discharge and discharges to
my said Trustees or the Survivor of them or the Executors Administrators
or Assigns of such Survivor for all monies payable to them or either of
them under the Trusts of this my will And as to and concerning the
said sum of Six hundred pounds before mentioned and deducted the
deducted out of my personal Estate as aforesaid Upon trust that they
my said Trustees or the Survivor of them or the Executors or
Assigns of such Survivor do stand possessed of the same ~~in~~ ^{and}
same upon such good Security as aforesaid and pay the Interest dividends
and Annual proceeds thereof unto my said dear wife Anne during her
natural life if she so long continues my widow And from and after her
decease or second Marriage Upon trust as to the sum of Two hundred
pounds part thereof to pay the Interest dividends and Annual proceeds
thereof towards the maintenance education and support of my said Son
William until he attains the age of Twenty one Years And upon his
attaining that age Upon trust to pay or assign over the said principal
sum of Two hundred pounds to him his Executors or Administrators And
as to the sum of Four hundred pounds the remaining part of the
said sum of Six hundred pounds Upon trust to divide the same
equally between my said Daughters Sarah and Rebecca share and share
alike I give devise and bequeath all Estates vested in me by way of
Mortgage with their and every of their appurtenances And all my
Estate and Interest therein unto my said Trustees their heirs Executors
Administrators or Assigns according to the nature of the said Estates
Upon trust to the intent that they my said Trustees or the Survivor of
them or the Heirs Executors or Administrators of such Survivor of them
or his Assigns do and shall on payment of the money due upon the
same respectively release reconvey assign and assure the same with the
appurtenances unto the person or persons who shall be entitled to
the Equity of redemption thereof or as he or they shall direct
Provided always and my Will is and I do direct that in the
event of either of my said Trustees dying or declining or becoming
incapable to Act it shall be lawful for the Surviving Trustee or
in case of his death of the Executors or Administrators of such Surviving
Trustee by writing under his or their Hand or hands when and as
often as he or they may deem it expedient to appoint some

competent person or persons to act with him or them in the Trust of
this my Will and from and immediately after such appointments the
said Trust monies and premises shall be vested in such new
appointed Trustee or Trustees in conjunction with the surviving Trustee
or the Executors or Administrators of such surviving Trustee as the
case may be to all intents and purposes as if such new Trustee or
Trustees had been originally appointed. And it is my Will that my said
Trustee or Trustees that may happen to be appointed under the power
hereinbefore contained shall not be liable answerable or accountable for
any loss that may happen to any of the Trust monies or otherwise in handling
any of the Trusts of this my Will unless the same shall happen by or through his or
their wilful neglect or default. Nor shall either of them my said Trustee or any
future Trustee or Trustees be answerable or accountable for the Acts deeds receipts or
disbursements of the other of them but each of them for his own Acts deeds receipts and
disbursements only. And I do declare and direct that the receipts alone of my
said Trustee or the survivor of them or the Executors Administrators or Assigns
of such Survivor or of such newly appointed Trustee as aforesaid shall be a
sufficient discharge or discharges for all monies payable to them under the Trusts
of this my Will and that the person or persons to whom the same shall be given
his her or their Heirs Executors or Administrators shall not afterwards be
answerable or accountable for the loss misapplication or nonapplication or be
obliged to see to the application thereof. And I do hereby direct and declare
that it shall and may be lawful for my said Trustee and all newly
appointed Trustee or Trustees to deduct pay and reimburse themselves and
himself all reasonable and necessary Costs Charges and Expences or
whatsoever that they or either of them shall or may ever sustain pay or
be put unto in or about the execution of this my Will or of all or any
of the Trusts hereby in them reposed. And lastly I do hereby nominate
and appoint the said Walter Lewis and William Lewis joint Executors
of this my Will and I do hereby revoke all and every other will and wills
by me at any time heretofore made and declare this only to be my last
Will and Testament. In Witness whereof I have to this my Will
the whole whereof is contained in Five sheets of Paper set my hand
and Seal that is to say my hand to the first four Sheets thereof and
my hand and seal to this Fifth and last Sheet thereof this Third day
